Our Meeting on 03/09/2023

WSSA met with District 3 Councilmember Sarah Perry and members of the Flood Control Board, Michelle Clark and Kate Akyuz, (plus support staff,) Steve Bleifuhs (River and Flood Plain Section Manager) and Chris Brummer (Supervising Engineer for Cedar River, Sammamish and White River Basins) At this meeting WSSA made specific requests. We made the "asks" in an attempt to refocus the Flood Control Board on addressing our critical flooding issues. They have prioritized Salmon Habitat and other issues they have taken on. They want to combine purposes, linking salmon habitat goals within many of their flood control expenditures. This includes the Sammamish River Flood Control Project, which for shoreline homeowners is the only way for flood waters to exit Lake Sammamish...except possibly our yards. We love the Salmon, just not in our basement.
